**Bookings**

- Bookings shall be on a first-come-first-served basis, subject to availability of tee times. The booking will only be accepted and confirmed when MBGC acknowledges the receipt of full amount payable.
- All bookings via facsimile or E-mail attachment are subjected to a 3% booking charge. Kindly note that we do not accept E-mail booking without our fax booking form.
- The person who does the booking shall be the lead golfer. MBGC will only accept instructions on name changes from the lead golfer. Only those golfers named on the booking will be allowed to play on the stipulated day.
- No changes to the date and/or tee time will be accepted once the booking has been confirmed by MBGC.

**Conditions of Play**

- Only golfers with latest / current official handicap certificates are allowed to play at MBGC. All handicap certificates must be from recognized golf governing bodies and associations.
- Upon registration, all golfers must produce ID cards/Passports and handicap certificates for verification purposes.
- All golfers are requested to check in 30 minutes before the time of play and report to the starting tee at least 10 minutes before their tee-off time. Any latecomers shall be rescheduled another available time slot and if there is no available time slot, the flight will be rescheduled to the last of flights or cancelled with no refund of green fee at the absolute discretion of MBGC.
- The use of buggies, on twin sharing basis, is compulsory.

**Cancellation**

- Cancellation of booking(s) must be made in writing by the lead golfer and sent via facsimile or email to MBGC no less than 2 days before the stipulated day of play. Otherwise, no refunds shall be made. Cancellation of booking will be effected only when MBGC acknowledges receipt of the cancellation in writing.
- Administrative charges of 5% will apply for refunds of golfing charges and/or night golfing lighting fees made via CashCards, NETS, AMEX, Visa or MasterCard credit cards.

**Refund Policy**

- Golf charges are non-refundable unless MBGC announces play for the day or session is abandoned.
- Refund of green fees only, by **way of non-transferable rain checks**, will apply only if the golfer(s) has not started playing the first hole. Refund of green fees **must be claimed on the same day in person**. Claim of refund on another day will not be entertained.
- There shall be no refund of any fees once the golfer(s) teed off.

**Golfers' Insurance**

- All golfers must have their own golfers' insurance.
- For those without, they must purchase their golfers' insurance from MBGC at **S\$5 per golfer on a per visit basis**, prior to teeing off.

**Important**

- All the terms and conditions, including the fees, charges and the notes are subject to changes without prior notice.
- MBGC reserves all rights to reject admission of non-conforming golfers. Recalcitrant golfers will be given warnings and/or asked to vacate MBGC. There will be no refund of any fees paid.
- Under no circumstances is NCI Golf Pte Ltd, the owner of MBGC, to be responsible for any injury or death howsoever or wheresoever caused to any visitors or golfers or for any loss or damage howsoever or wheresoever caused to the belongings or properties of the visitors or golfers.
